Performance reflects investment management fees, daily administrative fees, and mortality and expense risk charges.

Product Charges

The charges above do not include optional benefit fees which are more fully described in the contract prospectus. In addition to product charges, each subaccount/underlying fund may charge management fees and other expenses. The performance information provided here is net of applicable management fees and other fund expenses, which are subject to change and may vary for each underlying fund. Specific underlying fund fee and expense information is

available in the prospectus for the fund, which may be amended from time to time and can be obtained by contacting Nassau Customer Service.

CDSC: A surrender charge is assessed on withdrawals in excess of the free withdrawal percentage, and based on the date the purchase payments are credited. The surrender charge is waived if the withdrawal is due to the death of the owner, a Life Expectancy Distribution or if the annuity period has begun (except with respect to unscheduled withdrawals under Annuity Options K or L). In most states, a market value adjustment will apply to withdrawals prior to maturity from the 3-,5-,7- and 10-year fixed accounts.
