Specific underlying fund fee and expense information is

available in the prospectus for the fund, which may be amended from time to time and can be obtained by contacting Nassau Customer Service.

CDSC: A surrender charge is assessed on withdrawals in excess of the free withdrawal percentage, and based on the date the purchase payments are credited. The surrender charge is waived if the withdrawal is due to the death of the owner, a Life Expectancy Distribution or if the annuity period has begun (except with respect to unscheduled withdrawals under Annuity Options K or L). In most states, a market value adjustment will apply to withdrawals prior to maturity from the 3-,5-,7- and 10-year fixed accounts (state variations may apply).
